Terms of use

1. Overview

- The main objective of the National Bank of Moldova (NBM) official webpage (hereinafter website) is to ensure the presentation in a accessible, accurate, consistent and current manner of public interest information, regarding the work and decisions of the NBM, in compliance with Law no. 548 of 21.07.95, on the National Bank of Moldova, Law no. 239 of 13.11.2008 on transparency in decision making and Law. 982 of 11.05.2000 on access to information.
- Nevertheless, the NBM website is not an official source of information, the only official information is that published in the Official Gazette of the Republic of Moldova and other official publications available in hard copy.

2. Terms of Use

- The use of this website is conditional of total acceptance by the user of the terms and conditions of use.
- NBM is not responsible for any losses incurred by a person who bases its decisions, actions or inactions on the information published on the NBM website.
- Information published on the website constitutes the object of continuous reviews and updates. Therefore, the NBM reserves the right to make modifications in the content and structure of the website at any time, and without prior notice.
- NBM performs sustained efforts in order to keep the continuous functioning of the website, and to minimize possible interruptions. NBM cannot be considered liable for situations where the website or certain information published on it become unavailable for any reason, to the users.
- NBMs website is providing links to other sites, considered to be useful. Because they are not under the authority or control of the institution, NBM shall decline any liability concerning their content.
- Individuals who access the website of the NBM, as users, undertakes not to abuse in any way the content and functionality of the website, namely with reference to cyber-attacks, security vulnerabilities scans, reproductions of website etc. Otherwise, the violation of these terms will involve the responsibility of all guilty parties under civil and criminal legislation of the Republic of Moldova.

3. Copyright

- The copyright of the entire contents of thereof are entirely owned by the National Bank of Moldova.
- NBM allows free access to the information published on its website.
- Information published on the NBMs website may be copied or printed, for personal use only.
- The reproduction of the website pages, full or partial, and distribution in any form or kind and by any means is permitted only by indicating the source. I. case of processing by user, of statistical data published on the website, this must be mentioned explicitly. Also, if the information published on the NBMs website are integrated in documents intended for sale, legal or natural persons who publish such documents are required to notify customers both, before they make any payments, as well as the every time you access the information taken from the NBMs website, because information may be obtained free of charge from the NBMs website.
- The users have the right to put in their own pages links to the NBMs website, on the condition that the original context will be held, by opening a new window in order view it.

4. Personal Data

- NBM implicitly does not collect personal data about the NBM website's users. At each website access, NBM servers automatically record only information submitted by the visitor's browser (date and time of access, IP, browser type, etc.).
- But there are cases when, in order to receive a service through the website (ex. The feedback form, subscribing to press releases, news and other notices - RSS), will be requested some information of a personal nature (e.g., name, e-mail).
- In accordance with the legal framework for the protection of personal data, NBM ensures safe and personal data management, only for specified purposes which are provided. Recorded information will be used only by website administrators and by the NBM's structures which they are intended. Personal information collected will not be disclosed outside the institution.
