# Analysis of the volume of cash operations in domestic currency for January – April 2024

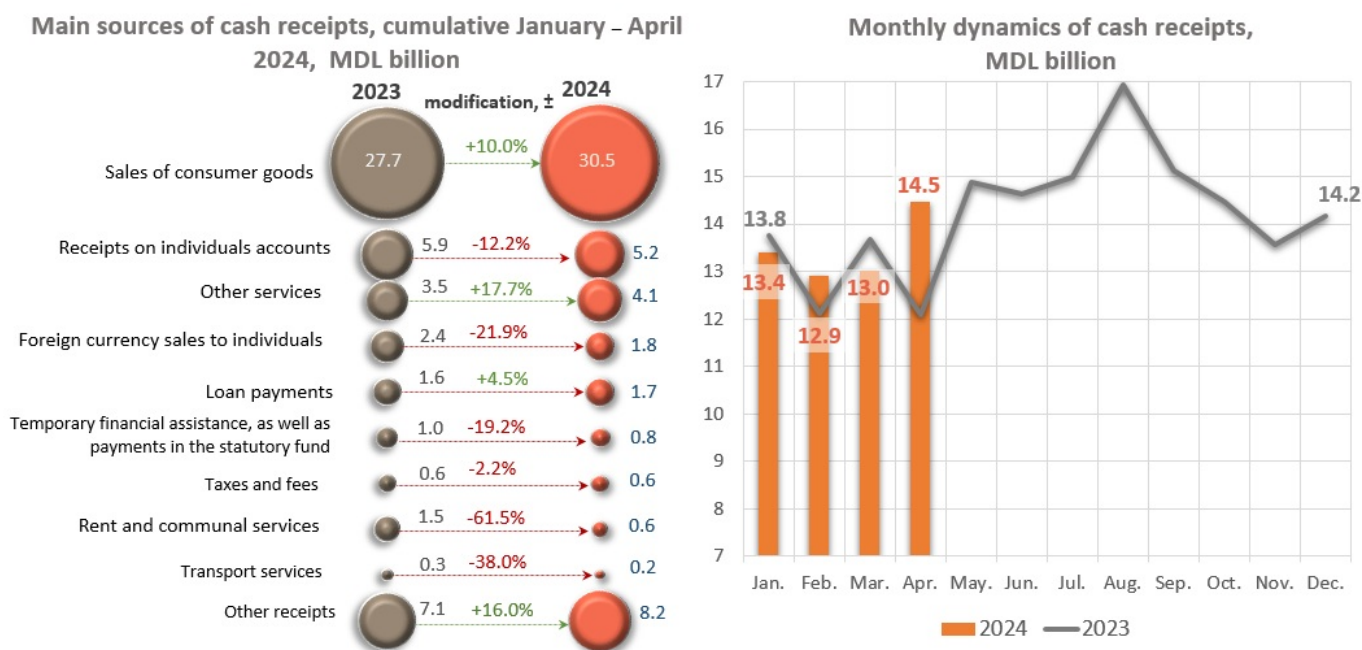
In January – April 2024 the volume of cumulative cash releases from banks exceeded the volume of cumulative cash receipts in the banking system<sup>1</sup> by MDL 220.3 million.

In the reference period, the volume of cumulative cash receipts increased by MDL 2,142.0 million (+4.1%) compared to the similar period of the previous year and amounted to MDL 53,770.2 million.

A significant increase was recorded in the receipts from the sale of consumer goods (regardless of the sales channel) by MDL 2,769.4 million (+10.0%) up to the total amount of MDL 30,481.5 million, which represents 56.7 percent of the total volume of receipts (Chart 1). Substantial increases were also recorded for other cash receipts<sup>2</sup> – by MDL 1,137.6 million (+16.0%), as well as for receipts from businesses that provide other services – by MDL 624.1 million (+17.7%).

At the same time, in January – April 2024, considerable decreases were recorded in cash receipts from payments for rent and utilities – by MDL 898.7 million (-61.5%), in receipts on current accounts and deposit accounts of individuals – by MDL 717.9 million (-12.2%), as well as for receipts from the sale of foreign currency to individuals – by MDL 517.3 million (-21.9%), amounting to MDL 1,843.3 million, which is the equivalent of USD<sup>3</sup> 103.8 million.

Chart 1. Main sources of cash receipts in banks vaults and their monthly dynamics<sup>4</sup>

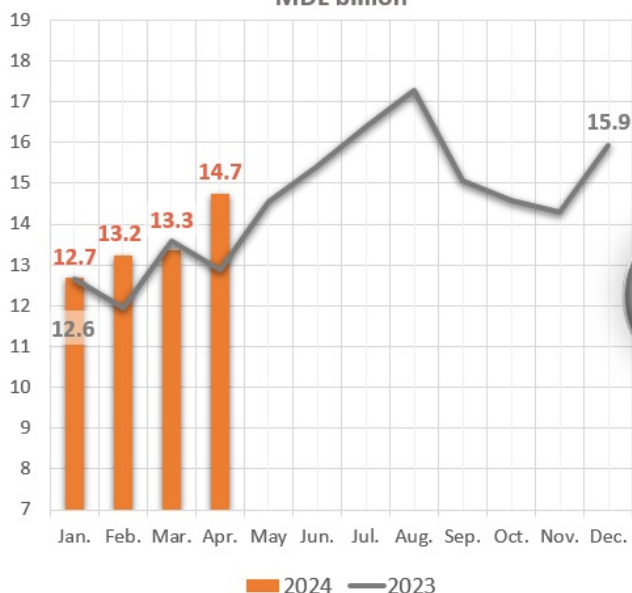

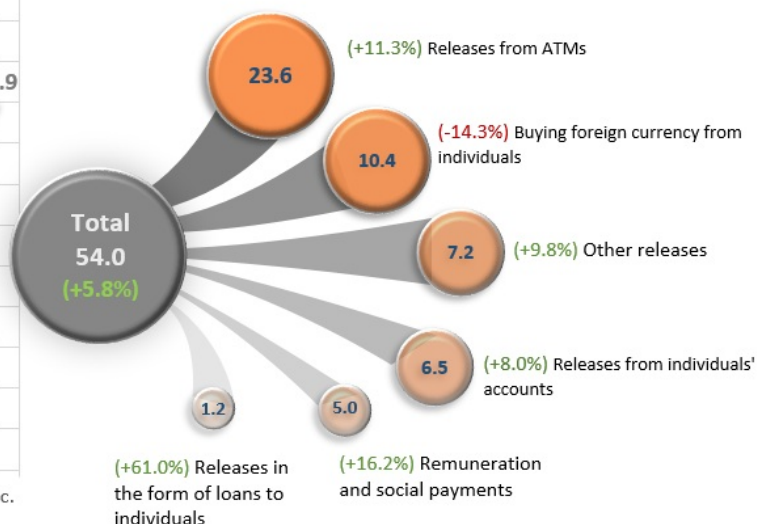
The volume of cash releases from banks in January – April 2024 increased by MDL 2,939.0 million (+5.8%) compared to the same period of the previous year and amounted to MDL 53,990.5 million (Chart 2).

The evolution of the volume of cash releases from banks was determined, on the one hand, by the increase of withdrawals from the ATM by MDL 2,406.9 million (+11.3%), of releases for work remuneration and social payments by MDL 703.3 million (+16.2%), of releases for other purposes by 639.6 million lei (+9.8), and on the other hand, by the decrease in the volume of cash released for the purchase of foreign currency from individuals, by MDL 1,738.5 million (-14.3%).

 Releases for other purposes = "Releases for the purchase of agricultural products" + "Releases of supplies to enterprises of The National Regulatory Agency for Electronic Communications and Information Technology of the Republic of Moldova" + "Releases for the payment of dividends, income, amortization and purchase of all types of securities" + "Releases for foreign exchange transactions based on settlement documents" + "Releases for the lease of rooms, as well as for the lease of land and other agricultural property" + "Refunds of payments into the statutory fund and temporary financial

assistance" + "Releases for other purposes.
