## Balance of payments of the Republic of Moldova in 2020 (final data)

In 2020, the current account of the balance of payments recorded a deficit of US\$ 892,51 million, which is -7,5% as a ratio to GDP (-9,3% in 2019). The capital account registered a negative balance amounting to US\$ 65,67 million, and the financial account recorded a net capital inflow of US\$ 1 042,13 million.
