The deadlines for the disposal of shares of B.C. “ENERGBANK” S.A. and “Banca de Finanțe și Comerț” have been extended

The Executive Board of the National Bank of Moldova (BNM) decided to extend for three months period the deadlines for the disposal of shares by the shareholders of B.C. “ENERGBANK” S.A. and “Banca de Finanțe și Comerț”, respectively. The extension concerns the shares, for which the NBM has previously imposed sanction measures for failure to meet the requirements of banking shareholding.
