Developments in loan and deposit markets in December 2022


Loans market

In December 2022, new loans extended¹ by banks totalled MDL 4,378.3 million, decreasing by 6.9% compared to December 2021.

The structure of loans granted (Chart 1) in the reporting month evolved as follows:

- 69.0% represents loans extended in domestic currency, which totalled MDL 3,023.1 million (+8.0% compared to the previous month and -12.6% compared to December 2021);
- 29.1% represents loans extended in foreign currency, which, recalculated in MDL, totalled MDL 1,273.6 million (-11.1% compared to the previous month and +10.9% compared to December 2021);
- 1.9% represents foreign-currency-linked² loans, which amounted to MDL 81.6 million (-32.8% compared to the previous month and -14.1% compared to December 2021).


Chart 1. Dynamics of new loans extended, million MDL (upper chart) and the annual growth rate of new loans extended by banks, % (lower chart)

In terms of maturity (Chart 2), loans with maturity ranging from 2 to 5 years recorded the highest demand, with a share of 47.1% in the total amount of extended loans. The share of businesses' loans extended to legal entities accounted for 37.0% in the total amount of extended loans.


Chart 2. New loans extended by maturity and their structure, %

Domestic currency loans (Chart 3) were mainly represented by loans extended to non-financial commercial companies (69.8%) and to individuals (19.1%). Within loans granted to non-financial commercial companies, loans to trade prevail (51.1%).

Foreign currency loans were mainly requested by non-financial commercial companies (92.9%), and the largest share (52.4%) belonged to trade.

The average nominal interest rate on new loans extended in domestic currency amounted to 13.97%, on loans in foreign currency – 5.13%, and on foreign-currency-linked loans – 5.48%.

Compared to the previous month, the average rate evolved as follows (Chart 4):


- on domestic currency loans, it decreased by 0.23 percentage points (p.p.). Businesses received their loans at an average rate of 13.28%, individuals performing an activity³ – at a rate of 17.02%, while individuals – at a rate of 16.46%;
- on foreign currency loans, it increased by 0.47 p.p. Businesses received their loans at an average rate of 5.07%,

individuals performing an activity – at a rate of 5.23%, and individuals – at a rate of 7.06%;

- on foreign-currency-linked loans, it increased by 0.11 p.p. Businesses received their loans at an average rate of 4.87, individuals – at a rate of 6.78%, and individuals performing an activity did not request any loans.

Compared to the similar period of the previous year, the weighted average nominal interest rate on domestic currency loans increased by 5.12 p.p., on those in foreign currency – by 1.19 p.p., and on foreign-currency-linked loans – by 1.27 p.p.


Chart 4. Weighted average nominal interest rates on new loans, %

The volume of domestic currency loans extended to individuals increased in December 2022 by 1.4%, as compared to the previous month, and totalled MDL 578.8 million (Chart 5). The average rate on these loans increased by 1.29 p.p.


From the perspective of the purpose of loans extended to individuals, consumer loans held the largest share (81.6%), and were extended at an average rate of 16.90% (+1.47 p.p. compared to the previous month and +6.54 p.p. compared to December 2021).

The average rate on mortgage loans extended in domestic currency increased by 0.12 p.p. compared to the previous month and by 5.44 p.p. compared to December 2021 and totalled 13.01%.

It should be noted, that 57.5% of total mortgage loans were extended in domestic currency. Consumer loans also were mainly extended in domestic currency (99.9% of total consumer loans).

Domestic currency loans (Chart 6) with maturity from 2 to 5 years (MDL 1,408.4 million, recording the highest demand in the reporting month), were extended at an average interest rate of 14.11% (12.87% – on businesses loans, 16.74% – on individuals’ performing an activity loans, and 16.86% – on individuals’ loans).


The highest average rate on domestic currency loans was registered on loans with maturity from 1 to 3 months and amounted to 15.67%.

Loans in foreign currency with terms of 2 to 5 years (MDL 633,7 million, which had the highest volume in the reporting month) were extended at an average rate of 4.87%, businesses received their loans at an average rate of 4.86% (MDL 630,3 million), individuals received their loans at an average rate of 6.83% (MDL 2.7 million), and individuals performing an activity received their loans at an average rate of 4.91% (MDL 0.6 million) (Chart 6).

Deposits market

In December 2022, the new term deposits totalled MDL 6,723.3 million, increasing by 2.2 times as compared to December 2021 (Chart 7).


The volume of new term deposits constituted:

- in domestic currency – MDL 3,970.9 million (-9.6% compared to the previous month and +92.5% as compared to December 2021);
- in foreign currency, recalculated in MDL – MDL 2,752.3 million (+12.7% as compared to the previous month and by 2.9 times more compared to December 2021).

The share of deposits attracted in domestic currency constituted 59.1% and of those in foreign currency – 40.9%.

Individuals' deposits (Chart 8) represented the largest share of total deposits – 70.3% (where, 43.1% represents domestic currency deposits and 27.2% – foreign currency deposits).

Chart 8. New term deposits placed by maturity and their structure, %



In terms of maturity, the highest demand was recorded for deposits with terms from 6 to 12 months, which held 42.6% of total term deposits. Individuals' deposits attracted at this term accounted for 33.1% of the total of deposits.

The average interest rate on domestic currency term deposits accounted for 13.26%, and on those in foreign currency – 2.46%.

Chart 9. Weighted average rates on new term deposits, %





Compared to the previous month, the average rate evolved as follows:

- on new term domestic currency deposits, it decreased by 0.35 p.p. Business placed their deposits at an average rate of 6.89%, individuals performing an activity placed their deposits at an average rate of 7.31% and individuals – at an average rate of 15.62%;
- on new term deposits in foreign currency, it increased by 0.67 p.p. Businesses placed their deposits at an average rate of 1.71%, individuals performing an activity – at an average rate of 0.50% while individuals – at an average rate of 2.85%.

Compared to December 2021, the average interest rate on domestic currency deposits increased by 9.13 p.p., while that on foreign currency deposits – by 2.07 p.p. (Chart 9).

Domestic currency deposits with maturity from 6 to 12 months, holding the highest share (46.0% of total deposits in domestic currency), were attracted at an average interest rate of 14.06% (businesses' deposits were attracted at an average rate of 8.33%, individuals performing an activity – at a rate of 10.37% while individuals' deposits – at a rate of 15.40% (Chart 10).

As concerns foreign currency deposits, the largest share (37.6%) is held by those with terms from 6 to 12 years, which were placed at an average interest rate of 2.01% (businesses placed their deposits at a rate of 0.64%, individuals – at a rate of 2.54%).

The highest average rate on domestic currency deposits was recorded as follows:


- on businesses' deposits with terms exceeding 5 years (9.04%);
- on deposits of individuals performing an activity with terms of 6 to 12 months (10.37%);
- on individuals' deposits with terms of 1 to 2 years and of 2 to 5 years (16.76%).

The highest average rate on foreign currency deposits was recorded as follows:

- on businesses' deposits with terms from 2 to 5 years (2.78%);
- on deposits of individuals performing an activity with terms from 3 to 6 months (0.50%);
- on individuals' deposits with terms from 2 to 5 years (3.63%).

Interest rate margin on domestic currency transactions constituted 0.71 p.p., while on those in foreign currency amounted to 2.67 p.p.

The interest rate margin on operations in domestic currency increased by 0.12 p.p. compared to the previous month and decreased by 4.00 p.p. as compared to December 2021 (Chart 11).

The interest margin on foreign currency transactions decreased by 0.20 p.p. compared to the previous month and by 0.87 p.p. as compared to December 2021.
