# Developments in loan and deposit markets in June 2022


#### Loans market

In June 2022, new loans extended by banks totaled MDL 4,346.1 million<sup>2</sup>, increasing by 9.0% compared to June 2021.

The structure of loans granted (Chart 1) in the reporting month evolved as follows:

- · 62.4% represents loans extended in domestic currency, which totaled MDL 2,713.1 million (+8.5% compared to the previous month and -7.3% compared to June 2021);
- · 35.7% represents loans extended in foreign currency, which, recalculated in MDL, totaled MDL 1,551.8 million (+5.3% compared to the previous month and +57.3% compared to June 2021).
- · 1.9% represents foreign-currency-linked<sup>3</sup> loans which amounted to MDL 81.2 million (-44.0% compared to the previous month and +11.7% compared to June 2021).



In terms of maturity (Chart 2), loans with maturity ranging from 2 to 5 years recorded the highest demand, with a share of 54.7%. The share of businesses' loans with this term constituted 39.7% in the total amount of extended loans.


New loans extended by maturity and their structure, %<sup>2</sup>



Domestic currency loans (Chart 3) were mainly represented by loans extended to non-financial commercial companies (53.2%) and to individuals (37.4%). Within loans to non-financial commercial companies, loans to trade dominated (47.9%).

Foreign currency loans were mainly requested by non-financial commercial companies (95.5%), and the largest share (46.8%) belongs to trade.


The average nominal interest rate on new loans extended in domestic currency constituted 11.34%, on loans in foreign currency - 4.04%, and on foreign-currency-linked loans - 4.55%.

Compared to the previous month, the average rate evolved as follows (Chart 4):

- · on domestic currency loans it increased by 0.79 percentage points (p.p.). Businesses received their loans at an average rate of 10.42%, individuals performing an activity<sup>4</sup> at a rate of 13.82%, while individuals at a rate of 12.52%;
- · on foreign currency loans, it increased by 0.08 p.p. Businesses received their loans at an average rate of 4.03%, individuals performing an activity at a rate of 4.75%, and individuals at a rate of 6.17%;
- · on foreign-currency-linked loans, it increased by 0.71 p.p. Businesses received their loans at an average rate of 4.13%, individuals performing an activity at a rate of 5.50%, and individuals at a rate of 4.80%.

Compared to the similar period of the previous year, the weighted average nominal interest rate on domestic currency loans increased by 4.55 p.p., on those in foreign currency it decreased by 0.06 p.p., and on foreign-currency-linked loans it increased by 0.61 p.p.

Weighted average nominal interest rates on new loans, %



The volume of domestic currency loans extended to individuals increased in June 2022, by 7.6%, as compared to the previous month, and totaled MDL 1,014.2 million (Chart 5). The average rate on these loans increased by 1.68 p.p.

Domestic currency loans extended to individuals<sup>2</sup>





From the perspective of the purpose of loans extended to individuals, consumer loans held the largest share (66.9%), and were extended at an average rate of 13.70% (+2.01 p.p. compared to the previous month and +8.87 p.p. compared to June 2021).

The average rate on mortgage loans extended in domestic currency increased by 1.38 p.p. compared to the previous month and by 3.54 p.p. compared to June 2021 and totaled 9.93%.

It should be noted, that 86.3% of total mortgage loans were extended in domestic currency. Consumer loans also were mainly extended in domestic currency (99.5% of total consumer loans).

The highest average rate on domestic currency loans was registered on loans with maturity from 1 to 3 months and amounted to 12.47%.


Loans in foreign currency with terms of 2 to 5 years (which had the highest volume in the reporting month) were extended at an average rate of 4.11% (businesses loans – 4.11%, individuals performing an activity loans – 4.92%, while individuals' loans – 6.42% (Chart 6)).

## Deposits market

In June 2022, the new term deposits totaled MDL 3,966.2 million<sup>2</sup>, increasing by 77.8% compared to June 2021 (Chart 7).

Dynamics of term deposits (upper chart) and change from the previous month (lower chart), million MDL<sup>2</sup>




The volume of new term deposits constituted:

- in domestic currency MDL 2,981.2 million (+26.0% compared to the previous month and 2.0 times more compared to June 2021);
- in foreign currency, recalculated in MDL MDL 985.0 million (+31.2% compared to the previous month and +33.0% compared to June 2021).

The share of deposits attracted in domestic currency constituted 75.2%, of those in foreign currency – 24.8%.

Individuals' deposits (Chart 8) represented the largest share of total deposits - 68,72% (where 56.1% represents domestic currency deposits and 12.7% - foreign currency deposits).

Chart 8 New term deposits placed by maturity and their structure,  $\%^2$ 



In terms of maturity, the highest demand was recorded for deposits with terms from 6 to 12 months, which held 53.5% of total term deposits (42.9% - individuals' deposits).

The average interest rate on domestic currency term deposits constituted 9.54%, and on those in foreign currency - 0.44%.


Compared to the previous month, the average rate evolved as follows:

- on term domestic currency deposits it increased by 1.34 p.p. Businesses placed their deposits at an average rate of 4.16%, individuals performing an activity—at an average rate of 1.61%, while individuals at an average rate of 11.36%;
- on new term deposits in foreign currency, it increased by 0.02 p.p. Businesses placed their deposits at an average rate of 0.42%, while individuals at a rate of 0.46%. Individuals performing an activity did not place any foreign currency deposits.

Compared to June 2021, the average interest rate on domestic currency deposits increased by 6.36 p.p., but that on foreign currency deposits decreased by 0.06 p.p. (Chart 9).

Domestic currency deposits with maturity from 6 to 12 months, holding the highest share (58.3% of total deposits in domestic currency), were attracted at an average interest rate of 10.93% (businesses' deposits were attracted at an average rate of 5.79%, deposits of individuals performing an activity - at a rate of 5.00%, while individuals' deposits – at a rate of 11.68% (Chart 10)).

In the case of foreign currency deposits, the largest share (39.2%) is held by those with terms from 6 to 12 months, which were placed at an average interest rate of 0.31% (businesses placed their deposits at a rate of 0.26%, individuals - at a rate of 0.37%).

The highest average rate on domestic currency deposits was recorded as follows:


- on businesses' deposits with terms from 6 to 12 months (5.79%);
- on deposits of individuals performing an activity with terms from 6 to 12 months (5.00%);
- on individuals' deposits with terms from 1 to 2 years (12.39%).

The highest average rate on foreign currency deposits was recorded at both businesses' deposits and individuals' deposits with terms from 1 to 2 years (1.0%).

Interest rate margin on domestic currency transactions constituted 1.80 p.p., while on those in foreign currency amounted to 3.60 p.p.

The interest rate margin on operations in domestic currency decreased by 0.55 p.p. compared to the previous month and by 1.81 p.p. to June 2021 (Chart 11).

The interest margin on foreign currency transactions decreased by 0.06 p.p. compared to the previous month, while compared to June 2021 did not change.

Individuals performing an activity, in accordance with the Instruction on completion by licensed banks of the Report on monetary statistics, approved by the Decision of the Executive Board of the NBM No 255 of 17 November 2011, Official Monitor of the Republic of Moldova No 206-215 of 2 January 2011, as subsequently amended and supplemented, work in associations without legal personality and are producers of goods and/or services for market, and namely, individual enterprises, farms, entrepreneur license holders, notaries, lawyers, bailiffs, etc.
