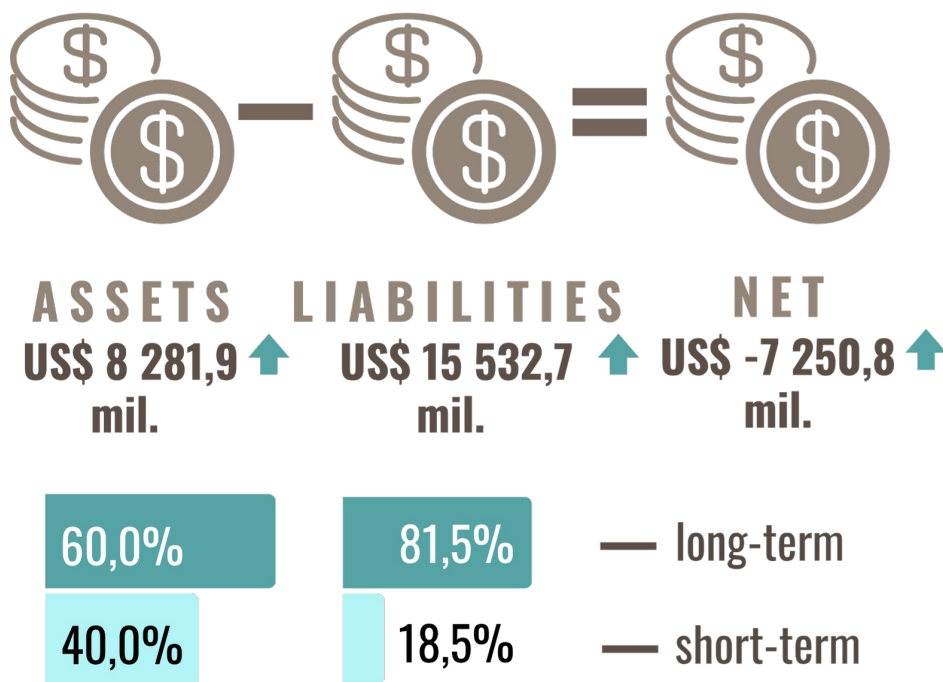

The net international investment position, as of 06/30/2025, recorded US\$ -7 250,82 million and increased by 19,3%, while the ratio to GDP accounted for 38,5%, by 5,1 p.p. more as compared to the end of 2024.

The external financial assets position amounted to US\$ 8 281,91 million, increased by 5,4% as compared to the end of 2024, while that of liabilities totalled US\$ 15 532,72 million and increased by 11,5%.

As of 06/30/2025, the net **international investment position** increased compared to the situation at the end of 2024, and relative to GDP accounted for -38,5%.
