# International accounts of the Republic of Moldova for 2020 (preliminary data)

[Statistical bulletin Nr. 1, 2021. International accounts of the Republic of Moldova for 2020 \(preliminary data\)](#) <sup>[1]</sup>

According to preliminary data, in 2020, the current account of the balance of payments recorded a deficit of US\$ 795,73 million, the capital account registered a negative balance amounting to US\$ 61,10 million, and the financial account recorded a net capital inflow of US\$ 942,62 million. The international investment position amounted to US\$ -5 493,85 million as of 31.12.2020, while the gross external debt totaled US\$ 8 357,73 million.
