

## Design procedure for jubilee and commemorative coins, issue 2022

**1. The organizer of the procedure:** National Bank of Moldova (hereinafter NBM), 1 Grigore Vieru Avenue, MD-2005, Chisinau.

**2. The object:** Design projects for jubilee and commemorative coins, issue 2022, with the following topics:

**"Personalities" series:**

Topic I: „Ion Neculce – 350 years since birth”;

**"Historical events" series:**

Topic II: "100 years since the coronation of King Ferdinand I and Queen Maria as sovereigns of Greater Romania";

**"Holidays, culture, traditions of Moldova" series:**

Topic III: "Vernacular architecture in stone";

**"Red Book of the Republic of Moldova" series:**

Topic IV: "Stone-blackbird (*Monticola saxatilis*)";

**„Childhood Stories” series:**

Topic V: „Childhood memories”;

**"Other" series:**

Topic VI: "Tree of Life" Country Brand;

**3. Participants:** all citizens who have reached the age of 18, as well as legal entities. By participating in the procedure and submitting design projects, each participant unconditionally agrees and undertakes to comply with the requirements of this procedure.

**4. Deadline for submission of design projects:** February 21, 2022, 14<sup>00</sup>.

**5. Announcing the results:** NBM will inform each participant about the results of the evaluation of the submitted design projects, following their approval by the governing bodies of the National Bank of Moldova.

**6. Requirements for the design and presentation of design projects:**

- a) only the participants who will present design projects for **at least two of the topic specified** in point 2 will be accepted;
- b) the maximum number of projects submitted by a participant for a topic is not limited;
- c) each design project is to be presented on **A4 paper, in electronic format**, as well as **the vector version**, as follows:
  - as a pencil / pen drawing or executed on a computer,
  - in black and white, except for topic no. IV, which will be presented in color,
  - with a diameter of 15 cm and, on the same page, in the version with a diameter related to 1/1 the size of the coin:
    - for topic I - with a diameter of 30 mm;
    - for topics II, III, IV, V and VI - with a diameter of 35 mm.

**Note:** For examination, the variant with a diameter of 1/1 to the size of the coin will be taken into account.

- d) each submitted project will contain a brief description of the design concept and the source of inspiration;
- e) each design project presented cannot be used in other projects (brands, medals, etc.):
- f) **the obligatory elements** of the design of jubilee and commemorative coins are:
  - for topic I - the face of the evoked personality, the years of life, images that characterize the activity of the personality and the inscription with capital letters “ION NECULCE”;
  - for topic II - the faces of King Ferdinand I and Queen Maria with respect to the main elements of the royals, the year of the coronation (1922) in the foreground, in the background elements that characterize the event of the theme and the inscription in capital letters „ÎNCORONAREA REGELUI FERDINAND I ȘI A REGINEI MARIA”;
  - for topic III - the image of the process of stone processing by a craftsman - stonemason at the capital in the shape of a water lily flower, characteristic element of the given topic, the symbol being specific to the Old Orhei area (Branesti, Butuceni, Trebujeni, Ivancea etc.) and the inscription with capital letters „ARHITECTURA VERNACULARĂ IN PIATRĂ”;
  - for topic IV - the colorful image of the bird species in 3D format and the capital letters „CARTEA ROȘIE” and „MIERLA DE PIATRĂ”, the inscription „MONTICOLA SAXATILIS”- italic;
  - for topic V - images from the work and the inscription in capital letters „ AMINTIRI DIN COPILĂRIE”.

In addition, the design of the leaflet with a size of 12 x 12 cm will be developed, in which the coin will be incorporated, with images from the work and the following inscriptions in capital letters: „2022”, „AMINTIRI DIN COPILĂRIE”, „ MONEDĂ COMEMORATIVĂ”, „20 LEI”, „COMMEMORATIVE COIN” and „CHILDHOOD MEMORIES”

- for topic VI - the image of the Country Brand "Tree of Life", as well as its elements in black and white. Please note the requirements described in the Brandbook, which can be viewed by accessing the link:

- g) each design presented must contain on the back:
  - the text “I hereby declare under my own responsibility that I have created this design, therefore, I confirm that it is original and complies with the provisions of the legislation on the protection of copyright and related rights.”;
  - name, surname and signature of the author of the design;
  - the date of signing the design.
- h) the participant in the procedure for the development of design projects shall submit personal data according to Form no. 1 (enclosed to procedure);
- i) coins design projects and signed Form no. 1 shall be submitted to the NBM in a sealed envelope bearing the inscription: **“Development of design for jubilee and commemorative coins, issue 2022”**.
- j) the envelope shall be submitted by participants in person or by registered letter, by the date and time indicated in point 4, to the following address:

- k) the participant can also submit coins design projects to the following e-mail address [corneliu.cretu@bnm.md](mailto:corneliu.cretu@bnm.md), specifying: **“Development of design for jubilee and commemorative coins, issue 2022”**;
- l) to be entered for this procedure, the participant shall make sure that they have received a confirmation of the NBM’s receipt of the design projects;
- m) all costs related to transportation / dispatch etc. of the design submitted in the respective procedure shall be fully borne by the participant;
- n) if requested by the NBM, the participant shall undertake to carry out, without additional remuneration, the final correction of the design projects in respect of which they shall transfer copyright (necessary changes and corrections arisen during execution of technological operations), within 5 calendar days from the NBM’s request.

**Note:**

- by submitting design projects for jubilee and commemorative coins, the participant in the procedure confirms his/hers availability to sign a contract on transfer of exclusive copyright allowing the NBM to use the design indefinitely, in case the NBM has selected and approved it;
- submitted design projects shall not be returned to participants.

**7. Examination:**

- a) the design projects shall be subject to examination and evaluation by a commission set up by the NBM;
- b) the commission shall select the most successful design projects (one for each jubilee and commemorative coin / leaflet);
- c) the commission shall propose the selected design projects to the governing bodies of the NBM for examination and approval, which, in turn, shall designate the winners of the competition;
- d) the governing bodies of the NBM reserve their express right to reject the results of the competition.

**8. Criteria for the selection of design projects:**

- a) compliance with the requirements presented by the NBM;
- b) clear and successful rendering of the coin’s topic;



- c) possibility of technologically executing the design on the surface of the coin:
- aesthetic, creative, and original character, clear visibility and coherence of the design elements in the version featuring a 1/1 diameter to coin's real dimensions ratio;
  - design elements that fall within the coin's surface area, without intersecting and overlapping with text or other design elements;
  - legible text and fine detail - not less than 1 mm;
  - design elements should not be overloaded with details that would appear as defects on coins / leaflets (e.g., abundance of vegetation elements or inlaid lines, etc.).

**9. Remuneration for the design projects selected by the NBM:** for each approved design project, the NBM shall sign with the participant a contract on transfer of property rights, including the exclusive property-related copyright in respect of the created designs.

The amount of the contractual remuneration shall vary depending on the theme and complexity of the presented design. From this amount, deductions at source shall be carried out, according to the tax legislation in force. If the NBM considers that elements of the design projects submitted by several graphic painters will be used for the approval of the final design project, the amount of remuneration shall be divided equally.

**10. Personal data:**

- a) by participating in the competition, the participant expresses their consent to the processing of personal data provided to the NBM;
- b) the NBM undertakes to maintain the confidentiality and use of personal data in accordance with the legislation in force;
- c) the organizer shall have the right to announce publicly the names of the winning participants.
