Rates on NBM Monetary Regulation Instruments

September 28, 2006

Taking into account the inflation dynamics and the current conditions of money market, the Council of Administration of the National Bank of Moldova, at its meeting of September 28, 2006, decided to raise by 0.5 p.p. the base rate of the National Bank of Moldova, applied on commercial banks' refinancing through SS two-month acquisition Repos conducted within NBM open market operations, to 13.0% per year.

Simultaneously, other interest rates in rates corridor have been set as follows:

- Overnight credits 17.0% per year;
- Lombard Facility 15.0% per year;
- Overnight deposits of commercial banks with the National Bank 2.0% per year.

The base rate on long-term credits (over 5 years) has been set at the level of 10.5% per year.

The decision of the Council of Administration on interest rates shall enter into force on the date of its publication in the Official Monitor of the Republic of Moldova.
