### Balance of payments for Q I 2018 (preliminary data) <sup>(1)</sup>

According to preliminary data, in Q I 2018, the current account of the balance of payments recorded a deficit of 189.96 million (that worsened by 51.2 percent as compared to Q I 2017), the capital account registered a deficit of US\$ 7.27 million and the financial account recorded a net inflow of US\$ 119.33 million.
