International accounts of the Republic of Moldova in 2018 (preliminary data)

According to preliminary data, in 2018, the current account of the balance of payments of Moldova recorded a deficit amounting to US\$ 1 186,71 million, the capital account registered a deficit of US\$ 39,38 million, and the financial account recorded a net capital inflow of US\$ 1 132,16 million. The international investment position amounted to US\$ - 4 166,92 million at the end of 2018, while the gross external debt reached US\$ 7 302,02 million.
