## Balance of payments of the Republic of Moldova for 2020 (preliminary data)

Statistical bulletin Nr. 1, 2021. Balance of payments of the Republic of Moldova for 2020 (preliminary data) <sup>[1]</sup>

According to preliminary data, in 2020, the current account of the balance of payments recorded a deficit of US\$ 795,73 million, which is 6,7% as a ratio to GDP (9,3% in 2019). The capital account registered a negative balance amounting to US\$ 61,10 million, and the financial account recorded a net capital inflow of US\$ 942,62 million.
