According to preliminary data, in Quarter II, 2022, the **current account** of the balance of payments recorded a deficit of US\$ 441,63 million, a 12,3% decrease as compared to the similar period of the previous year. The current account to GDP ratio amounted to -12,9%.

The **capital account** registered a negative balance amounting to US\$ 1,65 million, and the **financial account** recorded a net capital inflow of US\$ 465,79 million.
