According to preliminary data, in Quarter III, 2022, the current account of the balance of payments recorded a deficit of US\$ 618,20 million, the capital account recorded a positive balance amounting to US\$ 11,17 million, and the financial account recorded a net capital inflow of US\$ 526,46 million. As of 09/30/2022, the international investment position amounted to US\$ -5 686,98 million, while the gross external debt totaled US\$ 8885,50 million.
