According to preliminary data, in 2022, the **current account** of the balance of payments recorded a deficit of US\$ 2 275,20 million (US\$ 618,07 in Quarter IV, 2022), a 33,9% increase as compared to the previous year. The current account to GDP ratio amounted to -15,8%.

The **capital account** recorded a positive balance amounting to US\$ 20,17 million (US\$ 19,73 in Quarter IV, 2022), and the **financial account** recorded a net capital inflow of US\$ 2 357,17 million (US\$ 676,24 in Quarter IV, 2022).
