Pursuant to Article 27 paragraph 1 letter (c) of the Law No.548/1995 on the National Bank of Moldova (republished in the Official Monitor of the Republic of Moldova, 2015, No 297-300, Article 544), with further amendments, and Article 37 paragraph 1 of the Law No 202/2017 on the activity of banks (Official Monitor of the Republic of Moldova, 2017, No 434-439, Article 727), with further amendments, the Executive Board of the National Bank of Moldova

### DECIDED:

1. The Regulation on the granting of consortium loans by commercial banks of 03.02.1995, approved by the Board of Directors of the National Bank of Moldova, Minutes No 4 of 03.02.1995 (Official Monitor of the Republic of Moldova, 1995, No 38-39, Article 11) is hereby repealed.
2. This Decision shall enter into force on the expiry of one month from the date of its publication in the Official Monitor of the Republic of Moldova.
