## NBM Governor Anca Dragu's meeting with MEP Andrea Wechsler: another step forward in the irreversible European path of the Republic of Moldova

The Governor of the National Bank of Moldova, Anca Dragu, had a meeting with MEP Andrea Wechsler, member of the European Parliament Delegation for EU-Moldova relations. The discussions focused on the progress of our country in the process of accession to the Single Euro Payments Area (SEPA), a firm step in deepening European integration. Discussions also focused on the future of the Multiannual Financial Framework, underlining the financial support through the Growth Plan, to be put to a vote next week in the European Parliament.

"The National Bank of Moldova is actively involved in the process of negotiating the Republic of Moldova's accession to the European Union on multiple chapters. Together with other institutions, we are working intensively to speed up this irreversible process of European accession, which will bring more economic stability, a better and safer life for Moldovan citizens", said the Governor of the National Bank of Moldova, Anca Dragu.

MEP Andrea Wechsler appreciated the role of the NBM in the process of transformation and consolidation of the financial sector in the Republic of Moldova. Andrea Wechsler also expressed her strong support for the Republic of Moldova in the current geopolitical context, as well as for overcoming the energy crisis, emphasizing that "Moldova is not alone, it has reliable partners, and its place is with the European family." The MEP gave assurances that the European Parliament will provide continuous support to Moldova for the implementation of the Growth Plan.

The meeting took place during the working visit that Anca Dragu is making in Brussels, with the aim of strengthening cooperation with European institutions and advancing the process of financial integration of the Republic of Moldova into the European Union. In this way, Moldovan citizens and businesses will have access to sound, modern financial services that are favorable to economic development. During the last two days, the Governor of the central bank held talks with officials of the European Commission and had a series of meetings with Members of the European Parliament.
