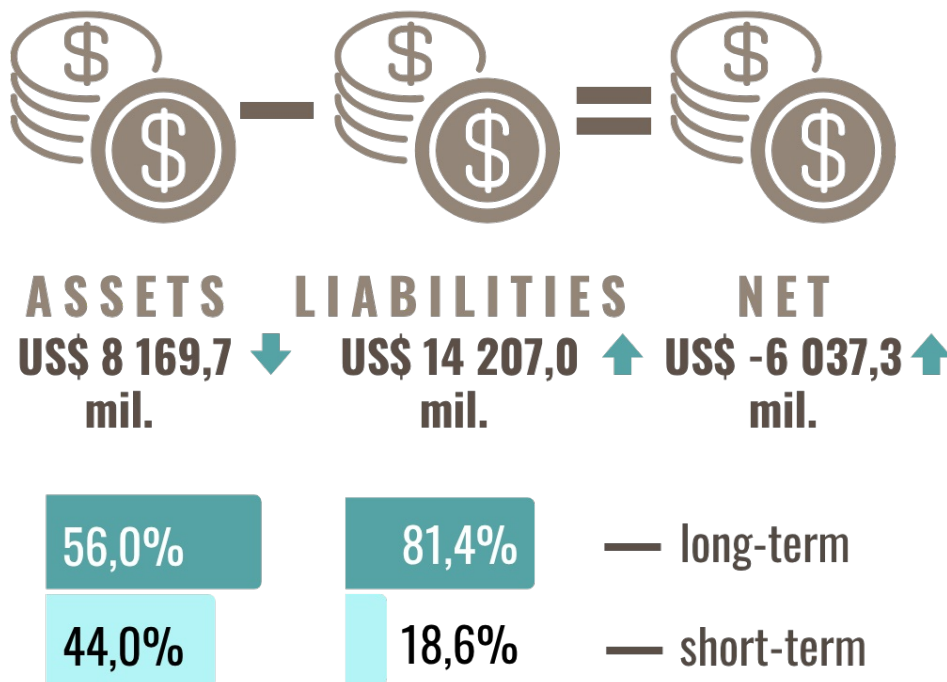

The net international investment position, as of 03/31/2025, recorded US\$ -6 037,33 million and increased by 8,0%, while the ratio to GDP accounted for 33,0%, by 2,3 p.p. more as compared to the end of 2024.

The external financial assets position amounted to US\$ 8 169,69 million, by 0,7% less as compared to the end of 2024, while that of liabilities totalled 14 207,02 mil. USD and increased by 2,8%.

As of 03/31/2025, the net **international investment position** increased compared to the situation at the end of 2024, and relative to GDP accounted for -33,0%.
