## Analysis of the volume of cash operations in domestic currency for January-September 2025

In January-September 2025, the volume of cumulative cash releases from bank vaults exceeded the volume of cumulative cash receipts in the banking system<sup>1</sup> by MDL 3,617.2 million.

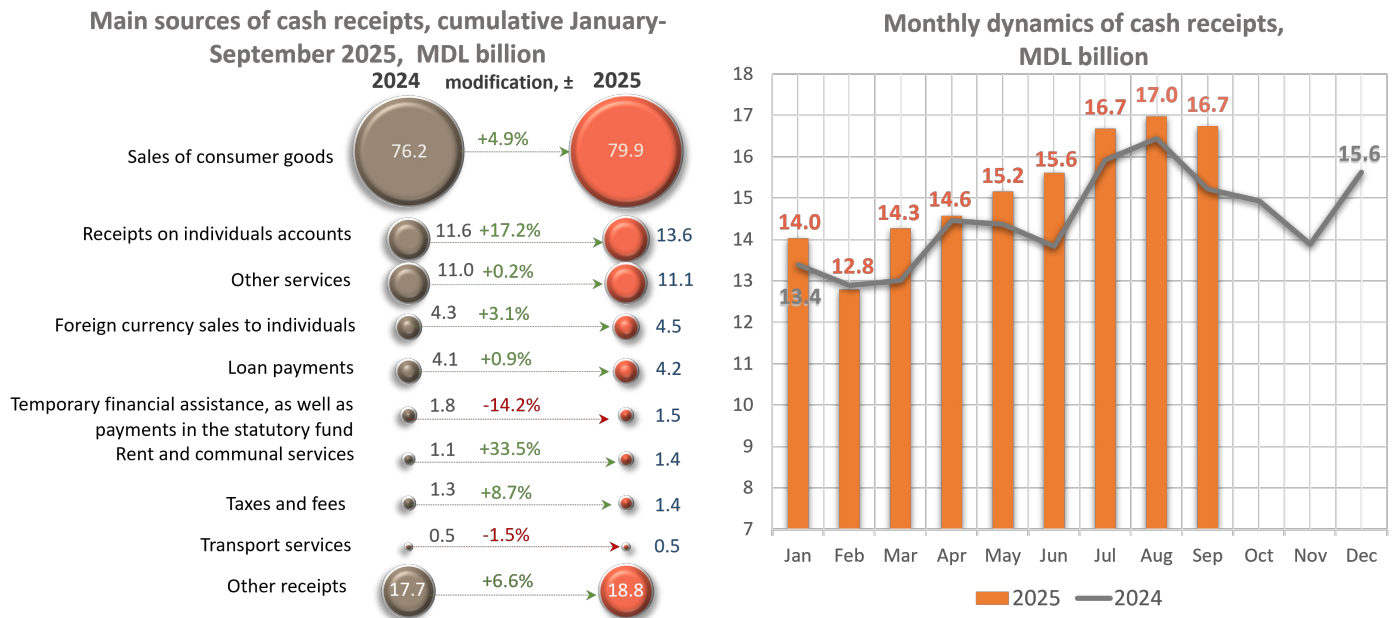
In the reference period, the volume of cumulative cash receipts amounted to MDL 136,864.6 million, increased by MDL 7,295.5 million (+5.6%) compared to the similar period of the previous year.

Cash receipts from the sale of consumer goods (regardless of the sales channel) amounted to MDL 79,866.5 million, representing 58.4 percent of the total volume of receipts (Chart 1), with an increase of MDL 3,712.8 million (+4.9%).

The volume of cash receipts in individuals' current and deposit accounts amounted to MDL 13,587.4 million, increasing by MDL 1,996.1 million (+17.2%).

At the same time, the change in the volume of cumulative receipts was also influenced by an increase in other receipts<sup>2</sup>, which amounted to MDL 18,827.1 million, up by MDL 1,171.2 million (+6.6%).

The volume of cumulative cash releases from bank vaults in January-September 2025 amounted to MDL 140,481.7 million, increasing by MDL 6,889.0 million (+5.2%) compared to the same period of the previous year.
