According to preliminary data, in Quarter III, 2022, the **current account** of the balance of payments recorded a deficit of US\$ 618,20 million, a 36,8% increase as compared to the similar period of the previous year. The current account to GDP ratio amounted to -15,5%. The **capital account** recorded a positive balance amounting to US\$ 11,17 million, and the **financial account** recorded a net capital inflow of US\$ 526,46 million.
