According to preliminary data in 2022, the **current account** of the balance of payments recorded a deficit of US\$ 2 275,20 million (US\$ 618,07 in Quarter IV, 2022), the **capital account** recorded a positive balance amounting to US\$ 20,17 million (US\$ 19,73 in Quarter IV, 2022), and the **financial account** recorded a net capital inflow of US\$ 2 357,17 million (US\$ 676,24 in Quarter IV, 2022). As of 12/31/2022, the **international investment position** amounted to US\$ -6 041,22 million, while the **gross external debt** totaled US\$ 9 457,80 million.
