

Developments in LOANS market in March 2024

In March 2024, new loans extended¹ (Infographic 1) totalled MDL 5,144.3 million, increasing by 12.1% compared to February 2024. The largest share (74.9%) represents domestic currency loans, which totalled MDL 3,852.1 million, increasing by 9.6% as compared to the previous month.

Infographic 1. Development in new extended loans²





In terms of maturity, loans with maturity ranging from 2 to 5 years recorded the highest demand, having a share of 59.6% in the total amount of extended loans. The share of these loans extended to businesses accounted for 41.1% in the total amount of extended loans.

The average nominal interest rate on new domestic currency loans as compared to the previous month decreased by 0.15 percentage points to the value of 9.48%, while the average interest rate on foreign currency loans increased by 0.02 percentage points to the value of 6.36%.

In March 2024, individuals contracted new loans in total amount of MDL 1,492.8 million, increasing by 7.5% as compared to the previous month, the largest share (67.7%) representing consumer loans (Infographic 2). The largest part of these loans (MDL 879.5 million) was extended in domestic currency with a maturity ranging from 2 to 5 years.

A share of 31.6% of total loans extended to individuals represent to mortgage loans, which were mainly extended in domestic currency (99.7% of all mortgage loans).

The average interest rate on consumer loans extended in domestic currency decreased by 0.22 percentage points to the value of 11.09%, while the average interest rate on loans granted in domestic currency to acquire real estate decreased by 0.07 percentage points to the value of 7.74%.


Compared to the previous month (Infographic 3), in the reporting month, businesses requested more loans, both in domestic currency (+11.2%) and in foreign currency (+23.1%), while foreign-currency-linked loans⁴ were requested by 23.5%

less.

Non-financial commercial companies contracted the largest share (64.5%) of new extended loans.


The average interest rate on domestic currency loans extended to businesses decreased by 0.17 percentage points, reaching 9.01%. At the same time, the average interest rate on foreign currency loans increased by 0.04 percentage points to the value of 6.36%.
