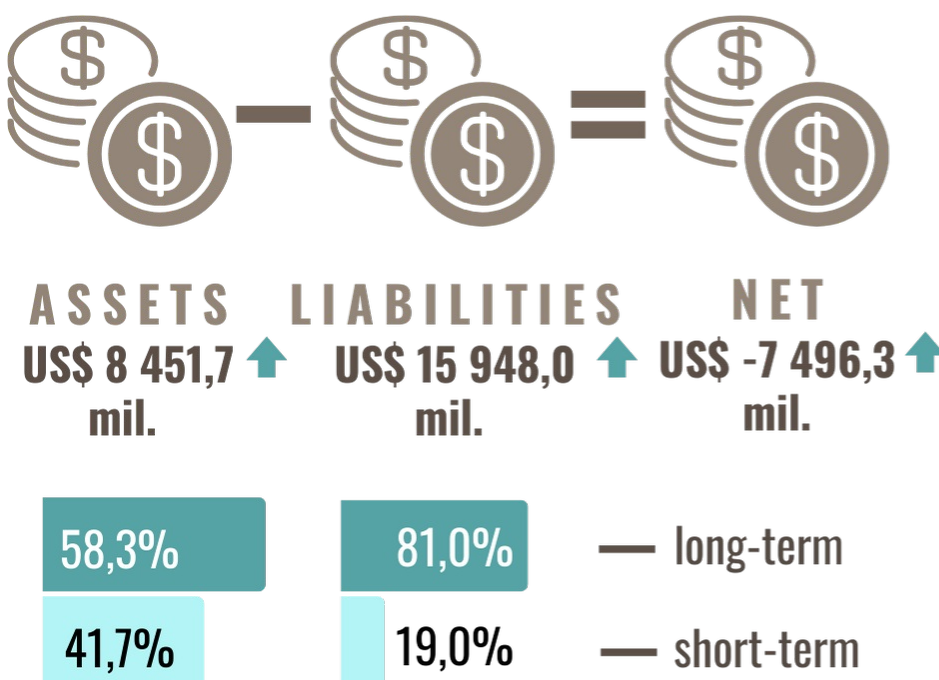

The net international investment position, as of 09/30/2025, recorded US\$ -7 496,25 million and increased by 23,4%, while the ratio to GDP accounted for 38,1%, by 4,7 p.p. more as compared to the end of 2024.

The external financial assets position amounted to US\$ 8 451,71 million, increased by 7,5% as compared to the end of 2024, while that of liabilities totalled US\$ 15 947,97 million and increased by 14,4%.

As of 09/30/2025, the net **international investment position** increased compared to the situation at the end of 2024, and relative to GDP accounted for -38,1%.
